CERTIFICATION

OBJECTIONS TO RELEASE OF FUNDS

HUD Region VIII will accept objections to its release of funds and the City of Minot's certification for a period of 15 days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are made on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Minot (b)

the City of Minot has omitted a step or failed to make a decision or finding required by HUD regulations at 2.4 CFR Part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before the approval of a release of funds by HUD Region VIII; or (d) another Federal agency, acting pursuant to 40 CFR Part 1504, has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to U.S. Department of Housing and Urban Development, Region VIII Office, 8ADE, 1670 Broadway Street, and Denver, Colorado 80202-4801.
