The City of Minot, North Dakota will be receiving Community Development Block Grant (CDBG) funds to be used for the construction of a thirty-five unit apartment complex. As federal funds are proposed to be utilized, your agency is given the opportunity to respond to any concerns or impact the proposed project may have with regard to environmental issues that relate to your agency.
