The City of Minot Engineering Department is requesting qualifications submittals for engineering services for the Downtown Infrastructure Improvements. The project will completely reconstruct approximately 26 blocks of downtown Minot between Broadway and 3rd St and Burdick Expressway and 1st Ave N.

The work will include the design of replacement sanitary sewer, watermain, storm sewer, concrete pavement streets, street lighting, traffic signals, concrete walks, and streetscape improvements. Construction engineering, surveying, project management, and record plans will also be required in the scope of services.

The US Department of Commerce, Economic Development Administration (EDA), is potentially providing partial project funding and consultants must follow all requirements associated with this potential funding. Storm Sewer District 119 and Street Lighting District 63 are also included in the scope of work and project funding.

Consultant must possess engineering staff capable of designing municipal infrastructure including trunk sanitary and storm sewers, and watermain, traffic signals, street lighting systems. Consultant must have experience with large scale infrastructure reconstruction projects. Consultant must also be able to perform utility modeling. Consultant will provide a public information coordinator throughout the design and construction phases. Consultant will perform project management, construction observation, and surveying throughout this multiyear project.

The City of Minot reserves the right to reject any and all proposals.
